New in 2010

- As of January 30, 2010, the City of Eden Prairie has implemented a new system for league registration and payment which requires that all **registrations and payment be processed immediately**. Checks will be deposited upon receipt.
- As the team manager, you now have the option to pay for your team registration with **cash, check or credit card**.

Registration and Payment

Payment can be made with cash, check or credit card – Visa, Mastercard or Discover. Registration forms without payment will be returned.

Registration Confirmation

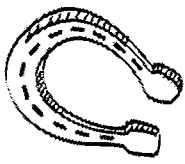
Assume your team is registered for your first league choice, unless you receive a phone call or email from the league director. Registration deadline is **MAY 21, 2010**.
